EPS factsheet for pharmacy staff


The improved prescription tracker allows you to check the status and history of electronic prescriptions.

Find by Prescription ID

The 'Prescription ID' uniquely identifies each prescription within the EPS. The ID is printed as a barcode and as text on prescription tokens.

Enter the ID exactly as it is printed on the prescription token, including the '-' characters.


Enter Prescription Details

If you don't have the unique Prescription ID then you can search for a patient's prescriptions using other information.

The 'Start Date Range' will be date of prescribing for the prescription(s) you are looking for.

The 'Prescription Version' can look for: all prescriptions, or EPS R1 prescriptions, or EPS R2 prescriptions which are fully electronic.

NEW 'My Site' feature — search for all prescriptions for your site. Note: This type of search will not return any results for users logged on using a Virtual Local Pharmacy (FFFFF) user role profile as prescriptions aren't associated with a virtual organisation.

Prescription Event History

A chronological event history for the prescription, or issue of a repeat dispensing prescription, is shown at the bottom of the prescription details page. Details of the prescription and dispensing events related to the prescription can be viewed by clicking on the Prescription ID link.

Guidance for each of the prescription "Status" values:

- Message - A short description of the transaction.
- Sent Date - The date and time of the event.
- Organisation - The Accredited System ID (ASID) of the EPS-enabled system that submitted the transaction. This is shown as a link which will display known organisation details for that ASID.
- From Status - The prescription status preceding the processing of the event by the EPS.
- To Status - The prescription status following the processing of the event by the EPS.

Benefits of the prescription tracker:

- Transparency for both prescribers and dispensers.
- Practice and pharmacy can check the current status of a prescription and can advise patients with confidence.
- Pharmacies can 'copy and paste' a Prescription ID (barcode) into their dispensing system to retrieve a prescription.
- Pharmacies can double check that a claim has been submitted, which is useful for expensive items.
