MACE	Multi- Agency Child Exploitation Is a multi-agency approach to identify high risk victims and offenders in relation to Child Sexual Exploitation offering added value solutions clearly identifying disruption and criminal justice responses to offenders.
MAPPA	Multi Agency Public Protection Arrangement (MAPPA) MAPPA is a set of arrangements established by Police, Local Authorities and the prison service in local areas (known as the Responsible Authorities) to assess and manage the risk posed by sexual and violent offenders.
MARAC	Multi Agency Risk Assessment Conference
MASH	Multi Agency Safeguarding Hub (MASH) The MASH is the single point of contact for reporting safeguarding concerns. It brings together a team of multi-disciplinary professionals from partner agencies into the same room.

PREVENT	Prevent is about safeguarding people and communities from the threat of terrorism. It is part of the Government's counter-terrorism strategy which aims to stop people becoming terrorists or supporting terrorism through radicalisation.
