


## EPS Prescription Tracker

An updated version of the EPS Prescription Tracker will be available as part of the Spine 2 implementation, operational from the 27th July 2014. This communication is intended for existing users of the EPS Prescription Tracker.

The functional changes within this application are:

- improved user interface, which also aligns with other national web-based applications delivered as part of Spine 2
- prescription search by NHS number, date range and prescription status
- tightened role based access control (RBAC) that controls user access to the application

**The EPS Prescription Tracker does not make available any clinical or sensitive information about a patient's prescription.** The application is designed to be used when there is a legitimate need to verify that a prescription exists or to identify a prescription status during the prescribing and dispensing process, e.g. which dispenser has downloaded it, when was it dispensed or has it been claimed.

This new web address should have been made accessible to prescribing and dispensing sites if your access is blocked, please contact your system supplier.

### **Additional information for system suppliers, NHS Area Teams and Clinical Support Units (CSUs)**

The tightened RBAC controls may mean that your organisation's RA sponsor may need to take action to ensure existing users of the Prescription Tracker retain access.

All system supplier, Area Team and CSU users who require access to the new EPS Prescription Tracker will require users to have one of the following activities included in their user role profile:

- B0278 'Perform Prescription Preparation' or
- B0570 'Perform Pharmacy Activities'

These are activities that EPS users in prescribing and dispensing sites will already have in their profiles, either directly or as included activities, so no action is needed for them.

The HSCIC EPS Programme recommends the following for users needing access to the EPS Prescription Tracker:

1. **Prescribing system supplier organisations.** Have B0278 added to their user role profile.
2. **Dispensing system supplier organisations.** Have B0570 added to their user role profile.
3. **NHS Area Team or CSU organisations.** Have B0570 added to their user role profile.

The tightened RBAC will ensure only those users with a legitimate need can track prescriptions using the new tool.
